#### Guidelines

Founders Fellowship was organized August 4, 2016, at Durham, North Carolina, by Mrs. Charles Robert Odom. The objectives are to afford the opportunity for national founders of hereditary organizations to engage in fellowship, and also to draw from the group a few volunteers who, if sought out, will serve to encourage and advise persons embarking on similar endeavors. An inquiring potential founder and volunteer members may interface in mutually agreeable circumstances so long as the forums are held apart from Council Meetings and Assemblies.

The Founders Fellowship Assembly will be held in the City of Washington, DC on the Wednesday before Patriots' Day Week unless changed by the Council of Fellows. Each member may be accompanied by one guest. When attending the Assembly, members are requested to wear the Founders Fellowship star and no other insignia, with exception granted for formal occasions. The organization's insignia should always be worn upon the left lapel or adjacent to a lady's heart upon her gown. It may also be worn to events of similar significance with other insignia while conforming to the stated placement. If an American Flag pin is worn the Founders Fellowship star shall be worn beneath it and parallel to any other leadership designations. Five blue spinels shall designate the Founding Council of Fellows insignia. No other star pins may carry the same designation

Business of the Founders Fellowship shall be conducted solely by the Council of Fellows that is authorized to meet in person, by telephone, Email, or U.S. Postal Service at the call of the President, or any five members of the Council. Five members of the Council shall constitute a quorum.

The President shall not serve more than two consecutive terms consisting of four years, although if reappointed, he or she may lead in a later term. A retiring President shall appoint his or her successor who will select the next Council of Fellows. At the discretion of the incoming leader, all other appointees may serve unlimited terms as well as hold more than one office although each may have but one vote.

#### Eligibility

Founders to include Co-Founders are individuals who initiated, or in certain circumstances revived national hereditary groups that have held an organizing-founding meeting followed by at least two annual meetings, if applicable. At the time of the invitation the organization founded should have a membership of at least forty persons not limited by residence of record. Inquiries are welcome and may be directed to the President. A copy of the Constitution and Bylaws of the prospective founder's organization shall accompany the candidate's response to the invitation.

While not required, members are encouraged to bequeath their star insignia to Founders Fellowship. Members are permitted to select one Successor Member legatee candidate for each group they founded and registered with Founders Fellowship. Upon the demise of a member, the Chaplain shall recommend to the Council for its consideration the legatee so named. At the time the invitation is issued, the candidate shall hold membership in the respective organization the deceased member founded. If the legatee candidate is not invited for whatever reason, or fails to join the Founders Fellowship upon invitation to do so, another member of the respective organization shall be invited to serve as Successor Member.

When attending the Annual Assembly, the Successor Member is requested to wear the insignia of the organization they represent.

#### Life Membership Fees

The fee for Regular Life Membership is set at \$175.00, which includes a Founders Fellowship pin and one membership certificate. Application may also be submitted for recognition within Founding Fellowship listings and a supplemental certificate for each additional group the member founded in the amount of \$20.00 at the time of application, or \$28.00 if submitted at a later date. To avoid bank fees at the outset of the organization of Founders Fellowship, life membership checks should be made payable to the Treasurer:

Successor Member life membership fee is set at \$60.00, which includes a certificate and listings within Founders Fellowship publications.

#### History of the Organizing of The Order of Descendants of the Justiciars

On November 15, 2011 Mrs. Sharon Stine initiated a new Order based upon lineal descent from Justiciars. Mrs. Carla Odom was appointed as Co-Founder. The following February Mrs. Ann Williams was invited to serve as a Co-Founder. Mrs. Stine was persuaded to adopt the title of Chief Justiciar. In March Mr. Barry Howard accepted the invitation to serve as Third Vice-Justiciar. Second Vice-Justiciar Williams filed for the Order's incorporation in Georgia.

Original plans were to hold the Founding Meeting during Heritage Season in Washington, DC in 2013, however, Second Vice- Justiciar Williams suggested the event be moved forward one year. The Founding Meeting also remembered as the Founding Convocation was held April 15, 2012 in the Library of the Army and Navy Club. This Order has the distinction of being the first lineage group ever remembered to utilize that space for that purpose. Those persons in attendance agreed all present who qualified for membership would be according the status of founding member. Third Vice-Justiciar Howard listed the Order's Founding Convocation on the HSC meeting schedule site at the outset. The Charter period was determined to begin immediately following the meeting and be held open until March 1, 2013. Mrs. Karen Miller and LTC Charles Odom were bestowed honorary membership and placed in appointed positions for the first administration.

The bylaws were adopted with revisions. Councillor Michael Schenk designed the splendid Justiciars shield that is utilized on official publications, membership certificates and insignia. Councillor John H. Jones granted wise advice for establishing a sound financial footing. First Vice-Justiciar Odom served as the initial Insignia Chairman and provided the

gentlemen's chest and neck ribbons and ladies; ribbons and sashes. Coordination was achieved with CityPride, LTD to produce the Order's regalia.

The Justiciars Journal was established as the official communiqué that was distributed in several issues a year to keep members abreast of the business and activities of the Order. A Spotlight section featured a number of the officers and council. The Charter and First Annual Convocation invitations were coordinated with Exchequer Michael Swisher who donated the Order's dies for embossing and special paper stock for membership certificates and invitations for application for membership. Auditors Roy Smith and Charles Robert Odom reviewed the financial records. Parliamentarian Karen Miller provided sound advice for the Order's convocations.

The Charter Convocation was held at The Army and Navy Club on Sunday, April 14, 2013. Third Vice-Justiciar Barry Howard brought a toast to the Order. A reception followed. Beautiful white roses and blue delphiniums were arranged in silver vases exhibited on the Grand Promenade, at the tea table, and throughout the meeting by Marshall Grantham Wood who was also elected Chairman of the Nominating Committee to serve with Shelby Ward and Carla Odom.

The First Annual Convocation was held on Palm Sunday, April 13, 2014 at the Army and Navy Club. Marshall Wood placed palm fronds for the head table and provided the flowers of the Order through the meeting room and adjoining areas. Chaplain Sally Hlavay brought prayers and a blessing in old English. The first slate of officers was elected. Shelby Ward conducted the installation service. Newly installed Chief Justiciar Carla Odom announced appointments. A delicious Tea followed the convocation. Order of Descendants of the Justiciars reached out with space and time to the Organizing Meeting of the Society of Descendants of Lady Godiva that followed immediately.

The first Scroll was edited for publication. The 2014 Issue of the *Justiciars Journal* was presented in full color copy by Editor Barry Christopher Howard.

The Second Annual Convocation was held April 12, 2015 as a joint Champagne Luncheon with the Hereditary Order of the Descendants of the Loyalists and Patriots of the American Revolution and the National Order of the Blue and Gray in the Grand Ballroom of The Army and Navy Club, Washington, DC. Co-Founder Ann Scott Williams Garner presented special gifts on behalf of the Order to other national leaders attending the event. Second Vice Justiciar Barry Christopher Howard presented program topic, *The History of Hereditary Organizations in the United States*. Councillor Michael Perry Schenk provided a brief program about his design of the Order's emblem and insignia. Bylaw amendments were adopted that clarified the recompense of the Keeper of the Rolls/Genealogist.

Chief Justiciar Odom appointed Mrs. DeEtte DuPree Nesbitt and Mrs. Princess Karen S. Cantrell as Honorary Members of the Order. Editor Barry Howard provided the 2015 Issue of the *Justiciars Journal*. A Scholarship Steering Committee was appointed comprised of the Honorary Members and First Vice Justiciar Ann Scott Williams Garner for the purpose of proposing to the board and in turn to the membership at the Third Annual Convocation a bylaw addition regarding adoption of a Scholarship Committee.

Order of Descendants of the Justiciars was invited by the Hereditary Order of Descendants of the Loyalists and Patriots of the American Revolution and the National Order of the Blue and Gray to hold a joint banquet on April 18, 2016 at the City Tavern Club in Georgetown. The proposed addition was adopted to authorize scholarships to undergraduate American citizens engaged in scholastic disciplines that support the Objects of the Order annually, or as voluntary contributions are available.

Co-Founder Mrs. Ann Scott Williams Garner was elected Chief Justiciar. She and the board of officers and councillors were installed by Founding Honorary Chief Justiciar Sharon Kaufelt Stine. A social hour and reception preceded the banquet that was followed by a program about the History of the Tomb of the Unknown Soldier.

#### WHO WERE THE JUSTICIARS?

In the Middle Ages Justiciars were appointed by the rulers of at least seven kingdoms, England, Wales, Ireland, Scotland, Sweden, Normandy and Lombardy. They were known as Lagmen in Sweden. A few Justiciars have been verified shortly following the Middle Ages. The emblem of the Order features the Lion of Justice holding the crown and castle. It is anchored by crests of the seven kingdoms. Justiciars were often noblemen, of sterling character who had proven loyal to the monarch. Prime Ministers are the closest modern equivalents of Chief Justiciars.

## Illinois Heritage Alliance

Illinois is fortunate to have people throughout the state who want to be actively engaged in multiple societies. It is a long state although many others are larger or longer, many individuals cannot attend and support meetings a great distance from home. Earlier there were scheduling conflicts when more than one group met on the same day, hundreds of miles away from members' homes or the other groups. Heritage Society members had to choose which organizations to attend. Many chose events that were the closest to home thereby saving travel time and expense.

A growing number of participants wanted to support to the meetings and were sad to miss many that seemed to fall close together or even over top of each other. In Illinois multiple Spring and Fall key dates are filled. Just about all the organizations schedule a business meeting, lunch, and program that with travel take most of a day. Participation in several of them means many days away from home and deep pockets for expenses and travel.

Something had to be done. I decided that Illinois should have a weekend devoted to Society Meetings. An email was forwarded to all the Presiding Officers who I knew informing them of the plan to initiate a weekend filled with all heritage meetings. We could find a hotel and have a mini Heritage Week in Illinois. We would be able to pool resources together and have professional speakers and programs.

On a cold January afternoon 9 Presiding State Officers met and decided to organize a Heritage Weekend in Illinois. They chose a date that day. Two hotels in the Peoria area seemed logical considerations. While Peoria isn't in the middle of the state, it's close. I teamed up with Kimberly Nagy and Sheri Worrell to review the hotels. Of the two one stood head and shoulders above the other. The Embassy Suites in East Peoria was selected.

The first Illinois Heritage Alliance was held the last weekend in September 2013. A total of 13 different societies held meetings on Saturday and Sunday. There were 2 lunches and a banquet. The Saturday luncheon had a speaker and the banquet featured a first-person interpreter entertainment. On Sunday the attendees had a wrap up lunch and decided on plans for the following year.

Every year we've added or changed something for the Alliance. There is an Educational Banquet on Friday night. Since 2013 participation has increased to 19 societies.

Members have the option to attend many more meetings than before the Heritage Weekend was established by the Illinois Heritage Alliance.
