- ❖ The Organization must show proof of no more than \$3,000.00 in liquid assets at the time of application.
- ❖ Applications MUST be received by the Founders Fellowship President no later than 31 December of the application year. The application and information submitted will be evaluated by the current Founders Fellowship Board and voted upon at the next annual meeting, with said vote being binding.

Instructions for application:

The current Presiding Officer of the Organization completes the application form, signs and sends to the Organization's current Treasurer.

The Organization's current Treasurer reviews the form, signs, and forwards to the President of Founders Fellowship along with all supporting documentation.

The application information must be postmarked on or before 31 December of the application year.
